ADDENDUM TO TUITION AGREEMENT

Distance/Remote Classroom Learning

The following terms amend that tuition agreement between the abovenamed school and the enrolled student's family/guardian, as evidenced by party signatures, below:

Distance/Remote Classroom Learning, 1 Upon execution of this agreement, the enrolled student's family/guardian is acknowledging and agreeing to the following: At any given time during the academic year, the School may convert to a distance/remote classroom learning model if deemed advisable or necessary by the School due to the occurrence of certain events (i.e., events of force majeure), and/or so as to otherwise safe-guard the well-being of the School and surrounding communities. Though in-person, on-site School classroom learning is the preferred and default method of the School's instruction model, distance/remote classroom learning may be required from time to time during the academic year, and for indeterminate periods of time. In such instances, the School has sole discretion² to determine if and when the School will activate its distance/remote learning model in place of its traditional in-person, on-site School learning model. A conversion to distance/remote classroom learning would generally occur upon an event beyond the School's control that prohibits or otherwise materially impedes the safe and/or prudent use of School on-site facilities for learning, inclusive of but not limited to acts of God, pandemic, government-imposed measures to the outbreak of infectious disease, quarantine restrictions related to an infectious disease, government regulations, disaster, strikes, civil disorder, terrorism, war, curtailment of transportation facilities, or any other unforeseeable cause, whether of the kind enumerated or otherwise. No modification to tuition. Any and all tuition due or otherwise already paid per the terms of this agreement will not be discounted, refunded or otherwise modified in the event the School must activate distance/remote classroom learning, except if modification is authorized in writing by the School upon the enrolled student's family/guardian written request that clearly articulates circumstances that the School determines, in the School's reasoned discretion, warrants tuition modification.

¹ Distance/Remote Classroom Learning means School instruction where the instructor and student are not physically in the same classroom location, generally occurring through a teacher's and a student's respective homes (or such other location as applicable) via both synchronous and asynchronous learning methods that could be, but are not limited to: online learning, blended learning, independent study, Web-based internet access on a School-approved remote classroom learning software platform, and/or any other method deemed appropriate for the effective delivery of distance/remote classroom learning.

² Additionally, School must adhere to any policy issued from the Archdiocese of Denver's Office of Catholic Schools on the topic of school facility closures, combined with community safety driven mandates (inclusive of those requiring facility closures) that may be issued by the Archdiocese of Denver through its Archbishop or other authorized office.
